FC DRIVE, an Illinois not-for-profit 501(c) (3) organization, independent contractors, and vendors are committed to providing the highest quality travel soccer experience for all participants. We work to the best of our ability to bring about the highest levels of player development and enjoyment of the sport.

COACHES COACH, PLAYERS PLAY, FAMILIES SUPPORT

Each family will exhibit positive support and encouragement for the players and coaches at all times and refrain from negative criticism about any player, coach, team administrator, and game official. Club activities are for and about our youth—there are positive life lessons to be learned.

EQUIPMENT

Each player will have the proper fitting shin guards, cleats, right size properly inflated soccer ball, and water bottle at each practice and game.

PRACTICE AND GAME CUSTOM

It is requested that each family help out with transportation to and from all practices, games, and tournaments and ensure that all players arrive on time—15 minutes before practice and 30 minutes before games are scheduled to begin.

EXCUSED ABSENCE AND ILLNESS

The player or family will inform the Head Coach in advance about each player's absence.

PROBLEM RESOLUTION

It is requested that each family inform their player's Team Administrator, Head Coach, Director of Coaching, and/or Director of Operations about issues, concerns or any dissatisfaction, so that a timely intervention and effective resolution can be made.

FC DRIVE FINANCIAL COMMITMENT AND PAYMENT SCHEDULE – 2009-10

The club relies on tuition to cover expenses for coaches, field permits, space leases, league fees, etc. FC DRIVE accepts checks, money orders, cash, and credit cards for payment of tuition and uniform fees. All players must purchase a new club uniform kit this year because Adidas is out of production on the current styles.

For payment by check, money order, and cash: Please submit full payment for tuition and club uniform kit fee at time of Registration. Please make check and money order payable to FC DRIVE.

For Credit card payment: Credit card users may submit full payment or pay two installments.

- U08 – U14      All players
- \$900 due by June 17 and balance \$700 due by August 24, 2009.
  - \$120 Club Uniform kit fee is due by June 17, 2009.

- U15-U19      Girl players:
- \$600 due by June 17 and \$500 due by August 24, 2009.
  - \$120 Club Uniform kit fee is due by June 17, 2009.

- Boy players:
- \$600 by June 17 and \$500 by November 13, 2009.
  - \$120 Club Uniform kit fee is due by November 13, 2009.

NOTE: A late payment fee of \$150 will be assessed for each tuition that is not fully paid by August 24, 2009 (November 13, 2009 for high school boys).

TUITION BACK GUARANTEE (AVAILABLE TO NEW PLAYERS ONLY)

Upon email request to a Director of Operations before September 15, 2009 (January 12, 2010 for high school boys)

- any 2009-10 tuition paid to-date will be refunded,
- the family's commitment to the club for that player will be cancelled, and
- the player will be released.

On September 15, any tuition paid to-date becomes non-refundable (except as noted below), and the player will not be released until the family fulfills the commitment to pay the full tuition. Uniform fees are not refundable at any time.

TUITION BACK FOR INJURY OR FAMILY EMERGENCY (AVAILABLE TO ALL PLAYERS)

Upon email request to a Director of Operations, tuition refunds for families of U08-U14 players who suffer a season-ending injury or family emergency will receive a refund check in the following amount:

- Before December 31, 2009      \$800
- Before March 31, 2010      \$400

FC DRIVE LIABILITY WAIVER/RELEASE

I, the undersigned parent/guardian of the below listed minor(s), fully understand and acknowledge that each participant will be engaging in activities that have risk of serious injury, including permanent disability or death, and social and economic losses which might result not only from their own actions, inactions or negligence, but actions, inactions or negligence of others, the rules of play, the condition of the premises or of any equipment used, and other unknown risks not reasonably foreseeable at this time.

I assume all the foregoing risk and accept personal responsibility for the damages following such injury, permanent disability or death, and hereby release, discharge, and covenant to indemnify FC DRIVE's directors, officers, employees, coaches, managers, agents, sponsors, or associated personnel including those of its affiliated organizations, and the owners and lessors of premises used to conduct events from any and all liability and against any claim by or on behalf of the participant as a result of his/her participation in the programs and/or being transported to or from the same.

The participant has received a physical examination by a physician and has been found physically capable of participating in the programs. I hereby give my consent to have an athletic trainer, coach and/or doctor of medicine or dentistry or associated personnel to provide the participant with medical assistance and/or treatment and agree to be financially responsible for the cost of such assistance and/or treatment.

After careful consideration, I hereby voluntarily authorize these players' participation in the programs. I have read the above waiver/release and understand that I will be giving up substantial rights by signing this release.
